Purpose of Visit: F43.10 PTSD, anger outburst and grief finding - to learn safe coping skills

Intervention PN: Mental Health Worker (MHW) started off meeting with a strength check in to support in improving communication. MHW introduced to client a "memory box" and how it can be used to put reminders of his loved inside and increase positive feelings. MHW worked alongside client in cutting and pasting positive words from a magazine like "strong, love and peace, etc". MHW worked with client in drawing a picture of his favorite memory with his mother so he could put it in his box. MHW talked to client that when he feels sad or angry, looking at his picture can help. MHW worked with client in finding a safe place to keep his memory box in his room. Client showed being engaged and was very open and smiling when talking about his favorite memory with mom.

Intensive Home-Based PN Plan: Plan for next session is to continue working on positive communication and his memory box to support to in decreasing his anger outburst.
