Diagnosis Treated Today : 1) Post traumatic stress disorder - acute (F43.11)*Purpose of Visit* : To review external records from Dr. Alfonso Mercado, Ph.D., psychologist for immigration, who was called to evaluate Cal after parents reported sexual abuse at the encampment while seeking asylum and entry into the U.S. Records were dated 9/1/2022.*Intervention* : Evaluator reviewed 10 pages documented report of abuse of minor while at the encampment across the border in Mexico. Parents were distressed when they discovered that their son was sexually abused by a stranger, while they were working away from the camp to buy food for the family. The abuse happened multiple times while parents were away. Sibling was also abused when a group of male youth were bullying and threatening to beat client up. When sister attempted to defend her brother, the youth forced the boy to run away threatening to kill him, while they raped his sister. Client did not disclose to Dr. Mercado any S/I or H/I at that time. He and the family did not want to be separated, and client did not want to talk to anybody at the time. Dr. Mercado diagnosed T74.22XA - Child sexual abuse - confirmed and Z59.0 - Homelessness.*MHS Assessment PN Plan* : Plan is to incorporate findings into 7 domain assessment evaluation.
