Purpose of Visit: Problem List: F43.11 PTSD - Acute; F32.9 Major Depressive Disorder, single episode, unspecified; F93.0 Separation Anxiety Disorder; F98.0 Enuresis' T74.22XA Child Sexual Abuse - Confirmed and Z59.0 Homelessness

Intervention PN: CFT - 90 Day Meeting - ICC Coordinator attended CFT meeting held for client's 90 Day review. This meeting was held 3 months following clients placement in the Orange County Child Welfare System. Client was transferred to Orange County SSA following detention and placement at the US border. Minor and 12 year old cousin were taken into custody by border patrol as they presented at the US border without accompaniment of an adult. Attendees included client, SSA Social Worker, CEGU Mental Health Therapist, CEGU Psychiatrist, CAST therapist and CASA worker. ICC Coordinator collaborated and coordinated with team to discuss initial assessments of client and discussed client strengths and needs based upon the reports shared by CAST and CEGU mental health primary therapist and interviews with Orangewood cottage staff. ICC focused on discussing and presenting the plan to coordinate services that client will receive via SSA and Mental Health working jointly together. Social Worker discussed and summarized for team client's entry into Child Welfare system and her subsequent placement at Orangewood. ICC provided a brief summary recommendations by mental health i.e. psychiatric evaluation and educational testing with bilingual provider as client is monolingual Spanish speaking only. Team also addressed clients continuing behavioral and social-emotional problems (crying, tantrums, hitting, fighting and enuresis) that may impact potential foster care placement options. As meeting proceeded minor remained quiet and refused to respond to inquiries to talk with team. She then had a meltdown and was taken out of the meeting by CASA worker.

Intensive Care Coordination PN Plan: Client is continuing to display labile affect and dysregulation at CEGU. Team was in agreement to continue to work on providing emotional support to client to continue to address her adjustment to Orangewood placement with goal of transition to a foster home placement. Will continue to monitor client's current placement adjustment and link to resources as indicated. CFT will meet again in 90 days or less to monitor client's progress.
